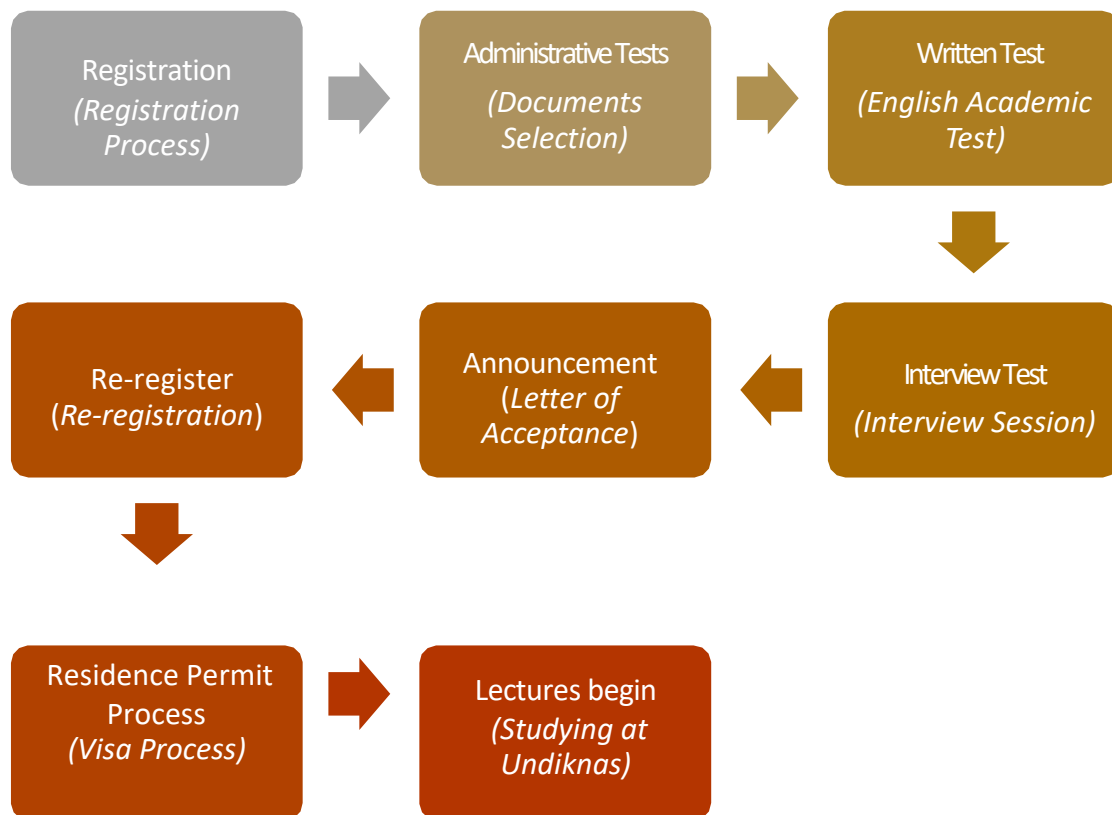


**FOREIGN STUDENT
RECRUITMENT SCHEME****Registrasi (Registration Process)**

The registration process is carried out by prospective foreign students via email internationaloffice@undiknas.ac.id or can access <https://io.undiknas.ac.id/>
Prospective students will send several documents such as the following:

- Scan Passport (Minimum validity period of 18 months)
- Newest photo
- Scan Academic Transcript and High School/Diploma 4/Bachelor/Master or Previous Study Certificate

Administrative Tests (Documents Selection)

Documents submitted at the registration stage will be processed and observed for 1 month. The International Office will check the status of prospective students such as immigration and study records of prospective students.

Written Test (English Academic Test)

Prospective students take a test made in English through Undiknas Mobile Application.

Interview Test (Interview Session)

Prospective students will conduct an interview session with the Head of International Office and the Head of the intended Study Program.



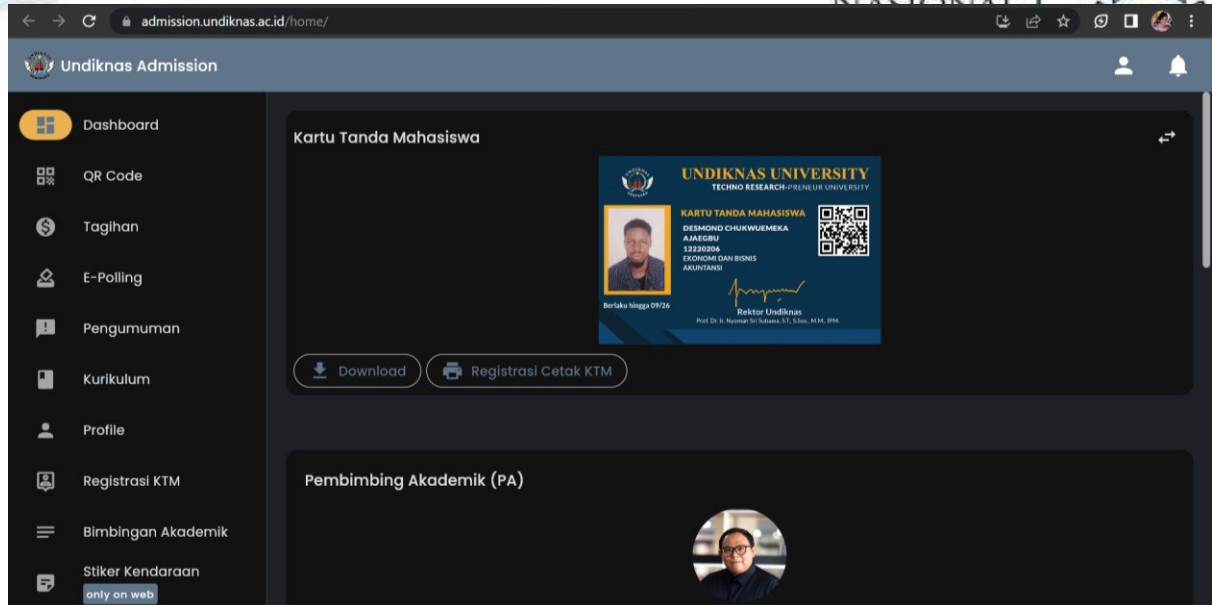

Residence Permit Process (*Visa Process*)

In the process while staying in Indonesia, foreign students will be reported in <https://izinbelajar.kemdikbud.go.id/> which is a website owned by the Ministry of Education and Culture of Research and Technology of Higher Education. Foreign students who already have a limited stay permit card (KITAS/KITAP) do not proceed to the residence permit process and are only reported to the study permit reporting page.

If the student does not have a Student KITAS, then the foreign student will process the study permit to the Ministry of Education and Culture on the page first. The requirements for a study permit are as follows.

- a. Scanned Study Permit Application Letter for Foreign Students from Higher Education addressed to the Institutional Director of the Directorate General of Higher Education, Research and Technology.
- b. Information related to the study program and personal data.
- c. Scanned Letter of Acceptance at Higher Education (LOA).
- d. Scanned Results of Diplomas or Academic Transcripts.
- e. Scanned Passport.
- f. Scanned Statement Letter for:
 - Will not work while studying in Indonesia.
 - Do not participate in political activities.
 - Comply with existing laws and regulations in Indonesia.
- g. Scanned Statement Letter from the guarantor or person in charge during study.
- h. Scanned results of the Certificate of Financing Guarantee.
- i. Scanned Health Certificate.
- j. Scanned passport-size color photos.

The study permit process for foreign students will be uploaded to the page and processed by the Ministry of Education and Culture within 3-7 working days from the time it is submitted by the student.

After obtaining a study permit, students will apply for a student E-Visa (C 316). Apply for an E Visa to be able to go to Indonesia and get a KITAS. This student is submitted on the page: <https://visa-online.imigrasi.go.id/>

Here are the requirements to get a Student E-Visa:

- a. Guarantee letter from the Guarantor who is an Indonesian citizen or Corporation
- b. Study recommendation letter from a government agency that organizes affairs in the field of education or religion.
- c. Proof of having received a full dose of COVID-19 vaccine;
- d. Valid and valid Passport of Nationality:
 - a. at least 12 (twelve) months for those who will do work in Indonesian territory for a maximum of 6 (six) months;
 - b. at least 18 (eighteen) months for those who will work or stay in Indonesian Territory for a maximum of 1 (one) year;
 - c. or at least 30 (thirty) months for those who will work or stay in Indonesian Territory for a maximum of 2 (two) years.
- e. Proof of having living expenses for himself and/or his family while in Indonesian region.
- f. Current account, passbook, or deposits of the last 3 (three) months belonging to the relevant Foreigner or Guarantor in an amount of at least USD 2000 (two thousand US dollars) or equivalent; proof of insurance ownership in an insurance company incorporated in Indonesia that includes health financing as long as the Foreigner is in Indonesian territory
- g. photos, with specifications: 1. Colour; 2. File format *. JPEG; 3. Size 100KB - 200KB; 4. solid white background; 5. photos taken within the last 6 months; 6. is not edited or imaged;
- h. Proof of having received a full dose of COVID-19 vaccine;
- i. A statement letter of willingness to comply with all applicable health protocols in Indonesia; and
- j. Proof of ownership of health insurance/travel insurance that includes health financing, and/or a statement letter willing to pay independently if affected by COVID-19 while in Indonesian Territory.
